Each roundtable brings together critical stakeholders from across Climate Group's networks to co-create a series of recommendations for short term action that will start to shift critical elements within key emitting systems, towards a net zero future.

Systems change for a net zero future requires radical collaboration which is only possible if these stakeholders work together and utilise their influence in specific areas. This series asks participants to share best practice, lessons learnt, and the challenges they face to support the development of key recommendations for short term action that can shift key systems towards a net zero future.

- **Share** cross sector and cross industry learnings to support systems shifts.
- **Support** the development of key action areas to shift systems in the short and long term.
- **Shift** critical elements and understand the levers that can result in shifting systems.

Objectives:

- **Prioritise:** Understand what must be prioritised to create systems change for the short, medium and longer term from different perspectives.
- **Prepare:** Learn from different stakeholders on how to prepare your organisation to have an impact and what you can do to contribute to shifting systems.
- **Pathways:** Develop a set of recommendations for business, governments, NGOs, and financiers to take real short-term actions and help shift the system being discussed.

Shifting systems – supply chains: *Leading Scope 3 emissions collaboration*

Overview:

Addressing Scope 3 emissions and driving supply chain resilience in the era of climate change could be the next big frontier for business action, but what does proactive collaboration really mean and how do we build resiliency into supply chains?

Leading on Scope 3 collaboration requires organisations to rethink how they engage with suppliers, taking a more collaborative approach to co-create solutions and adopt long-term changes to build resiliency. But to create fundamental shifts across industries, organisations must work together.

This roundtable brings together leaders from across the industry spectrum to share lessons learnt, best practice and the opportunities that lie ahead if organisations put competition aside and design collaborative strategies to tackle shared challenges.

Aims:

- **Share** best practice, advice and lessons learnt from current supplier engagement programmes and objectives.
- **Understand** how to measure success and engagement, what works and what needs to be improved.
- **Improve** efficacy of engagement through cross sector and cross industry learnings.
- **Radical collaboration** is needed across and between industries to deepen Scope 3 emissions collaboration and create resiliency across the sectors.

- Design a set of key action areas and recommendations for other organisations to meaningfully engage with stakeholders to address Scope 3 emissions and demonstrate why industry collaboration is greater than competition.
